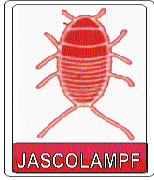

Bidder should enclose the following documents self certified in the technical bid (first envelope):

- a. Covering Letter on Letter Head of the Bidder (Format present as Annexure-I)
- b. Tender Fees - Demand Draft for Rupees Two Thousand Only in favor of “JASCOLAMPF” payable at Ranchi and drawn on any nationalized bank
- c. Earnest Money Deposit (EMD)
- d. PAN no. of the Agency/ Firm
- e. GST if applicable (Exemption Declaration/Certificate to be enclosed)
- f. SSI/NSIC/MSME Registration Certificate, Partnership Deed etc. (If applicable)
- g. Past Experience: Government Work orders/completion certificates etc.
- h. Experience Documents pertaining to supply/manufacture of Lac value added equipment's if any
- i. ITR for last 3 years

## **1. General Terms and Conditions:**

- i. Bidders shall quote the price for Lac Scraper cum Crusher machine in the given format in Annexure-II.
- ii. Any shortfalls in techno commercial bid will result in disqualification of the bidder and price bid will not be entertained by the Tender Inviting Authority
- iii. Earnest Money Deposit (EMD) amount of Rs. 1,00,000/- shall be deposited by the interested bidder in the form of Demand Draft drawn on any nationalized bank in favor of “JASCOLAMPF” payable at Ranchi. Tender without EMD and Tender Document Fees are likely to be rejected.
- iv. EMD is exempted for the bidders those having valid registration under Udyog Aadhaar and all micro and small enterprises registered with Director of Industries from DIC. To support this, the self-certified scan copy of such valid registration/ exemption certificate is to be attached with technical bid.
- v. Validity of rates and offer should be 12 months from the date of opening of tender.
- vi. Work order shall be reserved for L1 bidder and other bidders may be offered to supply on L1 rates for ensuring timely supply of items.
- vii. All documents to be typed, printed as per format, duly stamped and self certified as true copy (for photocopies)
- viii. The tender inviting authority reserves the right to cancel the tender, reject all tenders at any point of time without assigning any reason.
- ix. The Financial bid shall be opened for those bidders, those who qualify in the technical evaluation by the tender committee.
- x. Jurisdiction for any disputes arising out of the tender will be Ranchi, Jharkhand.

## **2. TERMS OF PAYMENT:-**

Payment will be made after supply of the items at the destination (At different district location of Jharkhand as mentioned in the delivery schedule) and receiving certificate issued by - a) Secretary / Authorized Signatory.

### **3. PENALTY CLAUSE**

Any delay from the stipulated schedule would invite a penalty of Rs. 500/- per day as enumerated in the Scope of Work indicated above.

### **4. QUANTITY**

The requirement mentioned in the tender document is tentative and subject to increase or decrease at the time of finalization of tender/work/supply.

Estimated requirement of Crusher Machine – 100 pcs.

### **5. CANCELLATION OF ORDER**

The authority issuing the order reserves the right to cancel whole or part of the supply orders of those suppliers, who are found to be defaulter for delayed supply of the items or the supply of non-standard quality of materials.

### **6. TERMINATION BY DEFAULT**

The Authority reserves the right to terminate the contract of any agency/agencies in case of changes in the JASCOLAMPF procedures or unsatisfactory services.

### **7. FORCE MAJEURE**

Neither party will be liable in respect of failure to fulfill its obligations, if the said failure is entirely due to Acts of God, Governmental restrictions or instructions, natural calamities or catastrophe, epidemics or disturbances in the country.

The party affected by an event of Force Majeure will immediately notify the other party of such an event and will also notify the unaffected party on cessation of disability resulting from such Force Majeure act.

### **8. ARBITRATION**

Venue of arbitration will be Ranchi and will be governed by provisions of the Indian Arbitration & Reconciliation Act.

### **9. JURISDICTION OF COURT**

The Civil Court, Ranchi shall alone have an exclusive jurisdiction to decide any difference, dispute and claim for and against JASCOLAMPF / BIDDER arising out in respect of the said NIT. The competent authority reserves the right to accept or reject any or all tenders without assigning any reason.
